- 8. <u>*Findlay First-*</u> Approved the appointment of Rev Jessie Myers as moderator effective October 1, 2018
- 9. <u>Marseilles & Forest</u> Approved a motion to require Rev Mary Curtis to take a course on Sacred Trust Boundaries.
- 10. Received Rev Michelle James of Presbytery of Detroit into MVP as a corresponding member.
- <u>Toledo, Eastminster</u> Approved the commission to install Rev Thomas James to Eastminster Presbyterian Church, Toledo on Sunday November 4, 2018 at 4 pm as follows: Rev Margaret Fox, Rev Susan Rowland Miller, Rev Michelle James and Ruling Elders Carole Burnworth (Eastminster), Lance Weisman (Britton, Raisin) and Jay Salvage (Presbytery Moderator).
- <u>Toledo Collingwood</u> Approved their MIF on the basis that the changes suggested by COM be considered under the guidance of Rev Karen VanderPloeg, and implemented if it is deemed appropriate.
- 13. <u>Galion</u> Approved receiving Rev Gary Proietti (Disciples of Christ) as a temporary member of MVP and authorized him to administer the sacraments at Galion and to moderate their session on the understanding that he takes an online Polity Class. Approved the contract between Rev Gary Proietti and the session of First Presbyterian Church, Galion to hire Rev Proietta as a Temporary Part-time pastor, commencing Sept 1, 2018, for a period of 1 year. He will be paid \$250 per week for preaching and pastoral care, working at least 10 hours per week. Vacation time will accrue at 3.5 days per month including 5 Sundays per year.
