Appointed the Rev. Karol Farris-Schilling as moderator of Dola Presbyterian Church effective August 16, 2022.

Action taken to lay aside the ordination of the Rev. Jorge Betancurt, per his request, and to release him from ordered ministry in the PC(USA), and to remove his name from the roll without prejudice. The Rev. Jorge Betancurt was member of our presbytery now living in Florida, and has transferred his credentials to the Church of God, which does not currently have a relationship with the PC(USA). Action taken May 31, 2022.

Action taken to transfer the membership of the Rev. Carol Pierson to Miami Valley Presbytery, at its request, effective June 1, 2022. Carol served as interim pastor at FPC Bryan and now been called to a church in Miami Valley Presbytery.

Renewed, effective July 1, 2022, as a validated ministry, the position of the Rev. Matthew Zuehlke, as pastor of Zion Evangelical Lutheran Church, Gibsonburg, OH.

Acted to validate the ministry of the Rev. Susan Rowland Miller with Habitat for Humanity as of June 14, 2022. The Commission invites Susan to speak to this ministry as well as her consulting work with Holy Cow! Consulting.

Approved the interim contract between the session of Christ Presbyterian and a team of pastoral leaders made up of David Bartley, Diane Christopherson, and Barbara Esterly, effective August 8, 2022. With the understanding that the transitional team is made up of co-equals, who have already met to assign preaching responsibilities and designate additional responsibilities, the Leadership Commission **appointed David Bartley as Moderator of the session** of Christ Presbyterian on behalf of Maumee Valley Presbytery. The annual contract terms are for the same hourly rate of \$ 33/ hour: The Rev. David Bartley: Salary \$13,920.00 and 403 (b) Salary Reduction \$20,400.00 The Rev. Diane Christopherson: Salary \$15,720.00 and Housing Allowance \$18,600.00

The Rev. Barbara Esterly: Housing Allowance \$17,160.00

Prorated four weeks vacation that includes 4 Sundays and appropriate Holiday pay.

Reimbursement for business travel and expenses. Estimate of \$3,000 for the Transition Team. Mileage at the IRS approved rate.

Termination notice of 30 days by either party. It is understood that all the Transition Team members positions will end with the start date of the new Pastor.

Each member will be scheduled to lead worship once a month and will be paid for pulpit supply if they preach a second time in the month.

Approved the dissolution of the Associate Pastor position at Christ Presbyterian Church, Toledo as of December 31, 2022.

Approved three contracts for pastoral supply for First Presbyterian Church, Fostoria, OH, as follows:

Dr. Marie Loudon Hanes (lay preacher and head of staff), (1/2 time, commencing June 5, 2022)-

Salary \$ 887 per month
Reimbursable expenses
Continuing Education \$ 900 per quarter

The Rev. Robert Butcher (Parish Associate) (1/4 time commencing June 5, 2022) –

The following amounts are per month –

The Rev. Mark Self (Ecumenical Associate) (1/4 time commencing June 5, 2022)-

Salary \$579 per month (Rev Self agrees to subrogate this compensation to the Trinity United Brethren Church in Christ). That congregation meets in Fostoria's building.

Authorized a payment of \$ 250 from the Pastoral Assistance fund #5304, for ½ of 6 prepaid sessions (\$500 total) for certified coaching for a member of presbytery.

Land Acknowledgement: Highlight of the First Peoples of Ohio



As we meet today in Norwalk, Ohio, we acknowledge the many Historic Native Peoples of Ohio who inhabited these lands well before it was called Maumee Valley Presbytery, especially acknowledging the Erie people, an Iroquoian group that lived on the south shore of Lake Erie before 1658, and whose descendants may be included among today's Seneca-Cayuga Tribe of Oklahoma. We acknowledge the Wyandot (Huron) who came later, along

with the Woodland people who over time have called this place home, like the Ottawa, Shawnee, Delaware, and Miami people.

We give thanks for all the First People of Ohio and their stewardship of the land.

We began a Spiritual Director Practicuum with Sr. Nancy Brousseau, a Dominican Sister out of Grand Rapids, Michigan. It is also a time in our development as Directors/Companions to get more practice. I recently posted in our newsletter, because a couple of us were still looking for potential directees. Because we are in a process of learning, this is offered free at this time.

Spiritual direction is "help given by one Christian to another which enables that person to pay attention to God's personal communication to him or her, to respond to this personally communicating God, to grow in intimacy with this God, and to live out the consequences of the relationship." (William A. Barry and William J. Connolly, *The Practice of Spiritual Direction*)

This relationship in Spiritual Direction (also called Spiritual Companioning) is a conversational one in which one Christian — who has been or is being trained in the "art" of Spiritual direction — serves as a companion to another Christian on the journey of faith, enabling and encouraging that person to pay attention, respond, grow, and live out what they are hearing and experiencing in their relationship with God.

The Rev. Wilson "Bill" Flann Wood, age 95, died Saturday, May 21, 2022 at his home in Adrian, Michigan. Bill was a long-time minister member of Maumee Valley Presbytery. Trained at McCormick Theological Seminary and ordained by Wabash Valley Presbytery in May of 1963, Bill served churches for 50+ years in installed and interim capacities in Plainwell and Belleville, Michigan; Canton, Warren, and Lisbon, Ohio; and including Adrian First Presbyterian Church, in Adrian, Michigan. The Rev. Dean Michael Carzoo, age 88, died Friday, July 22, 2022, in New Bern, North Carolina. Trained at Pittsburgh-Xenia Theological Seminary and ordained by Washington Presbytery in 1959, Dean served as pastor of Emmanuel United Presbyterian Church in Eighty Four, Pennsylvania and then First Presbyterian Church in Buckhannon, West Virginia, before serving as Associate Pastor at First Presbyterian Church in Findlay, Ohio for many years, beginning in 1969 and serving for 30 years. Central Support Commission Report

Since our last Presbytery Meeting in May, the Central Support Commission has met 4 times.

The following items are offered so that you may see where God has been at work in this presbytery:

- 1. Approved our minutes from the May 19 meeting where Nominating Committee members were affirmed to serve, and the minutes of the July 26 meeting.
- 2. The following item was an <u>action taken on behalf of presbytery</u>. At our July 26 called meeting, we processed a request from Tontogany to sell their manse:
 - To allow Tontogany Presbyterian Church to proceed with the sale of the manse (Inlot 108, in the Village of Tontogany, Ohio) with the proceeds to be used at the discretion of the session. Ken Wessler moved and Chas Myers seconded. After discussion, PASSED.
- 3. Considered and discerned staff salaries for 2023 in light of inflation and justice with cost of living changes. Approval is assumed in the budget presented to the presbytery.
- 4. Considered and discerned 2023 Per Capita noting that GA is up .87, Synod is the same, and MVP is up .50 for a total of \$38.60. Approval is assumed in the budget presented to the presbytery.

The following items are offered so that you may discern what the Spirit will say to us in the September stated meeting. ON RECOMMENDATION TO THE PRESBYTERY

1. Central Support Commission recommends to presbytery the approval of the proposed 2023 Budget.

Central Support recommends the attached proposed budget for 2023 noting that

- a. It includes a 10% staff raise
- b. It includes a per capita raise of \$0.50
- c. It uses investment drawdown of \$63,800.45 as well as the income from the sale of the Dorr Street property which is \$52,146.78. (Note that the presbytery has spent thousands over the years out of general revenue on the taxes of this property so we view this as having reimbursed the presbytery's prior spending.)
- d. Point of reference: The proposed 2023 budget assumes a negative annual balance of -\$10,026.15; The 2022 budget assumed a negative annual balance of -\$32.603.
- 2. Central Support Commission recommends to presbytery the following host presbytery sites, pending Sessions approvals.

3. Central support, via the Nominating Team, will present a **motion/nomination for Vice Moderator** to serve Maumee Valley Presbytery for 2023.

The following items are presented as information as we celebrate the ongoing work of Christ through the Church.

- 1. Central support met in retreat on Saturday, August 13 at FPC Maumee to discern the direction to which God is calling us.
- 2. In retreat, we named and celebrated the places that we have seen the church being the church, noting that they did not all happen on a Sunday morning or in a particular building or setting. Good News continued to be shared following the retreat.
- 3. Pamela Short led the retreatants in worship with creativity, inviting us to name what keeps us from seeing Jesus.
- 4. Matt Meinke helped re-orient us structurally, reminding the commission of the new presbytery organization established prior to the pandemic. Together we assessed the efficacy of the new organization and named places where improvements could be made. Discussion was also held discussing the challenges to churches and the "hurting places" post-Covid and post-General Assembly. In all this, the commission was challenged to work toward an organization that will help us follow Jesus and allow us to see Jesus, not as in a mirror dimly, but face to face.
