Amy Remaklus Brief Biography

Raised in the Roman Catholic tradition and exposed early on to children with disabilities, young Amy had envisioned her service to God would be through working as a nun and a pediatric nurse. During nursing school, however, Amy discerned God's call to ecumenical relationship within the Church, married life, and service through acute care nursing. In addition, Amy witnessed for the first time female leadership in the pulpit when she became involved in Toledo Campus Ministry at the University of Toledo. This changed the course of Amy's life.

Since graduation from UT in 2008, Amy has been an acute care and traveling nurse, homeschool teacher, and devoted volunteer in every Christian congregation of which her family has been part. While Amy has been a member of the Presbyterian Church (U.S.A.) since late 2012, she and her family have practiced ecumenicity throughout their five relocations in the past 14 years. Amy, her husband Jeff, and their four daughters have worshiped; participated; dedicated time, talent, and treasure; and grown in their faith and love for God in Catholic, Methodist, Presbyterian, Pentecostal, Episcopal, Lutheran, Apostolic, United Church of Christ, and immigrant congregations. They are currently members at Ottawa Presbyterian Church (OPC) and worship regularly with various Presbyterian congregations in Northwest Ohio and Sylvania United Church of Christ.

In 2017, Amy was already an active member and volunteer at OPC, serving as an adult Sunday School teacher, children's ministry coordinator, occasional worship leader, and community outreach volunteer, when God's call redirected Amy to studies at a Presbyterian seminary. With strong encouragement and support from many pastors (both inside and outside the Presbyterian Church), OPC's session, and family and friends, Amy and her family moved to Decatur, Georgia in June 2018. Amy started classes at Columbia Theological Seminary in August, obtained a part-time position as the children's ministry coordinator at Shalom International Ministry in November, and continued homeschooling her children. Amy completed her studies and time with Shalom International Ministry in May 2022.

Amy carries a Bachelor of Science in Nursing, a Master of Divinity, and Master of Practical Theology, as well as a spirit of care, compassion, and inclusivity into her new position as the Toledo Campus Ministry (TCM) Executive Director. Her passion for building relationships with those on the margins, learning alongside students, and striving to make the world a better place will help her greatly in her new position, where she is responsible for creating and overseeing programming that carries out the mission of TCM: Deepening spirituality, serving through love, nurturing authentic community, and healing holistically. While her primary focus will be with college students during the academic year, she has already started developing a sense of intergenerational community and support since her start date in July 2022.

In addition to serving at TCM, Amy plans to continue homeschooling her four daughters, engaging regularly with the Maumee Valley Presbytery in various capacities, serving on the Kirkmont Board of Trustees, being an active alumna at Columbia Theological Seminary, and supporting her husband's new position at Compassion Health Toledo. She can be found at her TCM office at 2086 Brookdale Rd., Toledo, Ohio; on the University of Toledo bike trail; visiting friends and family around the United States; and at home playing with the kids, gardening, and feeding the birds!

Amy Remaklus Statement of Faith

I believe in the Holy Trinity – God the Father, Son, and Holy Spirit. God has many names because there are limitations in using human language to express our understanding of God.

I believe God created this world. God created all things good and desires good in this world. God notices when things are not good and calls us to be creators of justice, mercy, and kindness.

September 20, 2022

For Action by Presbytery

The Leadership Commission concurs with the Discipleship Commission's vote concerning the call to Amy Remaklus as Executive Director of Toledo Campus Ministry by its Board to constitute this employment as a call to ministry, and **to recommend to presbytery that this call be a validated ministry, upon her ordination**. (please refer to the Discipleship's Commission Report.)

The Leadership Commission recommends

"That the ministry of the Rev. Dr. Darcy Metcalf as Assistant Professor of Religious Studies at the University of Findlay, Findlay, OH be validated and request her transfer of membership from Miami Valley Presbytery. The Exam Team of the Leadership Commission sustained her examination for fit as a member of the presbytery."

Darcy plans to attend the presbytery meeting and will give a brief synopsis of her work at U Findlay and interest in being part of the presbytery.

Actions Taken on behalf of Presbytery

Appointed the Rev. Karol Farris-Schilling as moderator of Dola Presbyterian Church effective August 16, 2022.

Action taken to lay aside the ordination of the Rev. Jorge Betancurt, per his request, and to release him from ordered ministry in the PC(USA), and to remove his name from the roll without prejudice. The Rev. Jorge Betancurt was member of our presbytery now living in Florida, and has transferred his credentials to the Church of God, which does not currently have a relationship with the PC(USA). Action taken May 31, 2022.

Action taken to transfer the membership of the Rev. Carol Pierson to Miami Valley Presbytery, at its request, effective June 1, 2022. Carol served as interim pastor at FPC Bryan and now been called to a church in Miami Valley Presbytery.

Approved the terms of call between First Presbyterian Church, Bowling Green and the Rev Dr Jeffrey A Schooley, beginning August 1, 2022 with the following terms.

Renewed, effective July 1, 2022, as a validated ministry, the position of the Rev. Matthew Zuehlke, as pastor of Zion Evangelical Lutheran Church, Gibsonburg, OH.

Acted to validate the ministry of the Rev. Susan Rowland Miller with Habitat for Humanity as of June 14, 2022. The Commission invites Susan to speak to this ministry as well as her consulting work with Holy Cow! Consulting.

Approved the interim contract between the session of Christ Presbyterian and a team of pastoral leaders made up of David Bartley, Diane Christopherson, and Barbara Esterly, effective August 8, 2022. With the understanding that the transitional team is made up of co-equals, who have already met to assign preaching responsibilities and designate additional responsibilities, the Leadership Commission **appointed David Bartley as Moderator of the session** of Christ Presbyterian on behalf of Maumee Valley Presbytery. The annual contract terms are for the same hourly rate of \$ 33/ hour:

The Rev. David Bartley: Salary \$13,920.00 and 403 (b) Salary Reduction \$20,400.00

The Rev. Diane Christopherson: Salary \$15,720.00 and Housing Allowance \$18,600.00 The Rev. Barbara Esterly: Housing Allowance \$17,160.00

Prorated four weeks vacation that includes 4 Sundays and appropriate Holiday pay. Reimbursement for business travel and expenses. Estimate of \$3,000 for the Transition Team. Mileage at the IRS approved rate.

Termination notice of 30 days by either party. It is understood that all the Transition Team members positions will end with the start date of the new Pastor.

Each member will be scheduled to lead worship once a month and will be paid for pulpit supply if they preach a second time in the month.

Approved the dissolution of the Associate Pastor position at Christ Presbyterian Church, Toledo as of December 31, 2022.

Approved three contracts for pastoral supply for First Presbyterian Church, Fostoria, OH, as follows:

Authorized a payment of \$ 250 from the Pastoral Assistance fund #5304, for ½ of 6 prepaid sessions (\$500 total) for certified coaching for a member of presbytery.

Announcements

The Commission strongly urges that sessions and their personnel committees take into account the rate of inflation (currently around 8%) when considering raises in their staff salaries for 2023.

In Sept 2019 the presbytery adopted a policy that established MINIMUM Terms of call for full time pastors- at 80% of the church-wide median effective salary for full time pastors for the previous year as reported by the Board of Pensions. For 2023, minimum effective salary for full time pastors is to be \$ 49,680 including housing allowance or \$ 38,215.38 plus manse (30% of cash salary). This is only a 1.5 % increase over the 2022 amount. The Leadership Commission will review this policy and bring any recommendation to presbytery later this year or early next year for subsequent years.

This 3- year index of salary increases of the presbytery's minimum effective salary does not include any cost- of- living analysis. As we know, the annual rate of inflation for 2022 is currently around 8% and a higher than anticipated rate of inflation is expected to continue in 2023. The Leadership Commission strongly urges sessions to consider the rate of inflation in making salary recommendations for pastors, CREs and all church staff as the sessions set budgets for 2023. **Please consider salary changes to cover as much of the cost-of-living increase as is feasible**. Some sessions are considering 4-8% increases; one session has already put into effect a 10% increase for all staff due to inflation. Any lump sum bonus for the year is also considered effective salary, and, like a salary increase, is subject to pension dues. Please note: Pastor Participation pension dues (for all installed pastors) will be **39% of effective salary in 2023;** this is the first percentage increase in several years.
