PERSONAL STATEMENT OF FAITH – LORA MANON

If I were to write my faith statement in one word, that word would be "LOVE."

I believe that the Bible is the Word of God; it is infallible and inspired. It is God's gift to us and to all believers, a gift of truth and our authoritative guide for faith and life. Through the working of the Holy Spirit in us, our hearts and minds are opened to God's Word and its application in our lives and in the life of the church.

I believe in Triune God, one God, above all others, but in three persons: Father, Son, and Holy Spirit. God is not made, but has always existed, even before the beginnings of this world. God is – the Great I Am – and was and always will be. God is sovereign. He is Creator, and He has made us all in His image. His creation work continues, working in our lives and in our world, bringing new life and restoration. By His hand we are chosen, called and beloved. He is the Covenant God of the Old Testament, the one who is ever faithful.

I believe in God's only Son, Jesus Christ, Lord and Savior, who was present at the Beginning, and who became God with us, God in the flesh, fully man yet fully God. Jesus came as the fulfillment of prophecy and Scripture. Through Christ's ministry here on earth, God's love and grace were made known. Through Christ's sacrificial death on the cross, we are redeemed from our sins; He paid the price of our ransom so that we move from death to eternal life – a new covenant, sealed with the blood of God's only begotten Son. After His death and resurrection, Jesus ascended into Heaven, where He intercedes for us. Christ will come again and will reign in glory.

I believe in the Holy Spirit, who was made known at Pentecost, through wind and fire. He is also fully God and was also present at the beginning of time. The Holy Spirit is active and moving among us even now; He gives us power and equips us with understanding of God's Word. The Holy Spirit is our advocate and our comforter, a gift from God.

I believe that through the sacraments of baptism and communion we experience what it means to be the body of Christ. We respond to God's gift of grace with gratitude, returning thanksgiving and bearing witness to the gospel good news of salvation. Through the sacraments we remember all that Christ has done for us, and we recognize that we are all part of God's family, called, chosen, and beloved.

I believe that we have been created to worship God with all our hearts, souls, minds, and strength. We are created to be servants not only of God but of our neighbors. We are called to be disciples, to make new disciples, and to share the good news of the gospel. We are called to new life – a new life made not of works alone but built on faith. We are created to glorify God and enjoy Him forever.

WRITTEN SENSE OF CALL – LORA MANON

From my earliest years, I have felt the tug of God's call on my life. In various ways, I have attempted to answer that call and to serve when and where I perceived that I was needed: Sunday School teacher, Elder, Deacon, within the several ministries of my church, through music, and through the life of the church. And yet, I have continually felt that there was more that I have been called to do.

I distinctly remember telling my brother (now a pastor of a Presbyterian church in the Pittsburgh area) when he told me that he was going to seminary that I was intensely jealous and envious of him. But I likewise told him that I was not ready or able to give up my life and my career to take such a bold step. Even today, I am not sure that I am ready to give up a career that has been almost a ministry of sorts to take on a full-time pulpit call. There are practical reasons for this as well as selfish ones, I suppose.

However, I cannot ignore that I am still being called to serve in a way that incorporates preaching and teaching in Christian community. My training in the CRE program has heightened this sense of call, and that cannot be ignored either. I have found encouragement through my Union seminary professors/instructors to pursue this calling to leadership as a CRE; my classmates, too, have offered grace and encouragement as I look to new work in the church.

So, after much reflection, I submit that I am feeling called to where I can best be of use. Ideally, I could be assigned to a part-time call at a church. But if that call is to serve as pulpit supply only, then I am happy with that as well. I ask only that I might serve with a faithful heart and that I might rightly discern where I should be. Moreover, I ask that I might always "seek justice, love mercy, and walk humbly with my God."

Temporary Ministry Covenant with a Lay Minister between Lora Manon and Tontogany Presbyterian Church

This Covenant between the Session of Tontogany Presbyterian Church, Tontogany, Ohio and Lora Manon is for the purpose of providing pastoral services by a lay minister to a congregation within the Maumee Valley Presbytery. It will be renewed annually with the concurrence of the Session, the lay minister, and the Committee on Ministry of Maumee Valley Presbytery. It is agreed that this covenant may be terminated upon two weeks written notice by either the lay minister or by the Session.

The lay minister will:

- Prepare and lead worship services, including the order of worship, sermons, and weekly children's messages.
- Provide pastoral care for the congregation and for those who seek comfort and guidance through the church. This will include visiting shut-ins and those hospitalized, working together with the Worship and Care committee.
- Provide premarital counseling and preside at weddings once authorized by the Maumee Valley Presbytery, the church Session, and after all appropriate filings/registration with the State of Ohio are complete.
- Preside at funerals, after receiving permission of Session and Maumee Valley Presbytery to do so
- Be active in some form in the Presbytery
- Maintain office hours as mutually agreed upon between the Session and the lay minister
- Attend Session meetings, and once authorized, moderate the Session meetings.
- Attend committee meetings for the church as required
- Work part-time, not to exceed 25 hours/week. Obtain pulpit supply for those Sundays when she will be absent from the pulpit.

The complete Terms of Call for Year 2020, beginning March 1, 2020

The position is part-time, 25 hrs/week. At this time, Lora has not yet completed the requirements of the CRE (Commissioned Ruling Elder) program. When those requirements have been completed and she has acquired approval from the Presbytery, her salary will be re-negotiated to at least meet the minimum requirements of a CRE position. If the position requires more than 25 hours a week, Lora will work with the Session to determine how to proceed.

Note: These are vouchered items. Continuing education needs to be approved by Session. Professional expenses include travel/mileage at current IRS reimbursement rate for professionals, hotel stays as needed for hospital visitations, books, and technology. Once Lora has completed the CRE work, this package will increase to the values for a commissioned ruling elder.

<u>Vacation</u>: 2 weeks (at 25 hrs/week) and 2 Sundays (required) until CRE requirements are met, at which time this increases to 4 weeks and 4 Sundays. Five Sunday vacation days already agreed upon this year include: 3/22/20, 5/10/20, 6/14/20, 6/21/20, and 11/29/20. The pulpit will be filled using pulpit supply.

<u>Continuing Education</u>: 1 week (at 25 hrs/week), including 1 Sunday(required) until CRE requirements are met, at which time this increases to 2 weeks and 2 Sundays

SECA: to be paid by lay pastor, as this position is considered by the IRS to be self-employment

Dr. Nancy Berkheiser's Statement of Faith

I believe in one Almighty God who created the universe and everything that is in it. I believe God exists in the Trinity of the Father, the Son, and the Holy Spirit. I believe Jesus is God's only Son that God sent to earth to help us with our daily lives and to forgive us of our sins so that we might have eternal life if we believe in Him. I believe God looked down at us and realized we needed to have someone we could relate to; someone that experienced the same joys, hurts, frustrations, etc. that we also experience on a daily basis. There is nothing that will happen to us that Jesus does not understand. He lives among us, taught us God's principles and was an example for how we need to live our lives.

God told May, a young virgin, that she would conceive and bear God's child. The child would be called Jesus and He would save people from their sins. He would take the sins of the world upon Himself so that we might be forgiven. Jesus was crucified, died and was buried. On the third day, He ascended into heaven and lives there with God. Someday known only to God, He will come again and take all the believers home to be with Him forever in heaven.

When Jesus went to heaven, He told us that He would not leave us hopeless and alone. When we accept Him as our savior and Lord, the Holy Spirit comes into our lives and helps us live our lives as God wants us to. Through the Holy Spirit, Jesus is as close to us as every breath we take and we can call on Him anytime we need Him.

I believe I am a child of God and as such I am loved, forgiven, and walk with Him daily. He is my Lord and Savior, my teacher, my comforter, my joy and my friend; I can face each day confident and unafraid because I know He is with me and is guiding my steps. I cannot explain all the miracles that God has done but the wonderful thing is that I don't have to "explain" them. All I have to do is believe them and walk on in faith. I am so grateful that God loves imperfect people.

I believe that the **Bible** is the inspired word of God. For Christians, the Bible is the most authoritative source of our faith, principles, and practices. It is our "road map" for living a Christian life. The Bible was not written by God but by people who were believers and were inspired by God to reveal God, and His principles to everyone.

The Sacrament of **Baptism** unites us with Jesus and makes us a member God's family, the church. It is a sign of God's great love for us. In Baptism we are cleansed from sin and made new and clean and fresh. Our "new nature" centers in God and His ways. When we are baptized, we declare our personal faith in Jesus. It is baptism that starts us on our spiritual journey. The longer we know Him, the more we will grow in our spiritual growth and development.

When we are baptized we promise to do certain things: we commit our lives to Jesus and accept Him as our Lord and Savior; we follow Jesus; we obey God and live according to His word; we love other people; we try not to sin; and we rely on God's grace for salvation. As a church family we promise to assist the person on their spiritual walk with the Lord.

Communion is grounded in the "Last Supper," the final meal that Jesus shared with His disciples the night before His arrest and crucifixion. This is a meal that Jesus calls His followers to eat and God does something miraculous within us and for us when we eat this meal together in this way. Communion is a gift from God for us. It is coming to Jesus' table to be fed spiritually. At His table we eat and drink just as His disciples did before He died for us on the cross, and we are satisfied. Communion is a privilege given to the undeserving who come in faith, repentance, and love. In preparing to receive communion, a person is to confess their sins, to seek reconciliation with God, other people, and to trust Jesus for cleansing and renewal.

When we participate in communion, we affirm the following; that Jesus is our only hope; that we reaffirm our baptism that we repent of our sins and cling to God's grace; that we belong to God not because we are worthy but because God has offered us the gift of salvation; that we belong to God's family (church) and He intends for us to live in fellowship with those people; and we will try to live faithfully as followers of Jesus and members of God's community.

- K. Provide or assist with special services throughout the year including Ash Wednesday, Lent, Maundy Thursday, Good Friday, Easter, Thanksgiving, Christmas Eve and other services deemed necessary by the Session.
