





# 3 Boundary Training Resources for Sessions and Anti-Racism Policy

# Templates are coming

I have been promised that Boundary Training Resources are coming. There is a team of fellow General Presbyters who are working on modules that will be for use at the Session level.

The new Book of Order requirements include a boundary training requirements and timelines for Sessions. There are also Anti-Harassment and Anti-Racism policy requirements. All of



these are OPPORTUNITIES to live into our best selves. Remember that a policy is not an end, but a means to an end. This is an opportunity for us as churches and as a presbytery to get at some of those deeper challenges that Matthew 25 calls us, to be leaders in racial justice, helping communities flourish, address affordable housing, and exhibiting the kingdom of heaven to the world. This can all <u>start</u> with a good policy!

At the last meeting I shared a Sample Anti-Racism Template for congregations, and another template for this presbytery. These are the same templates being shared with every presbytery in the Synod of the Covenant. The hope is that many of our presbyteries will adopt similar policies, and similar training expectations, allowing for a team approach at the Synod or national level. A task force is forming at the presbytery level, including CCE Leslee Kirkconnell and myself, to help write our MVP policy. If you would like to be a part of this process, talk with me.

Regarding anti-harassment policies, I encourage you to reach out to your insurance provider, ask for their samples or recommendations.

Perhaps you want to ask a task force of your session to look at all the new policy requirements, which includes boundary training at the session level.

# 6 Death Notice



The Rev. Dr. Ann Marie Montgomery, age 68, died Thursday, December 7, 2023 in hospice care in Toledo, Ohio after a battle with cancer. Ann Marie was the pastor of Cadmus Presbyterian Church in Adrian, Michigan and a minister member of Maumee Valley Presbytery. Trained at Louisville Theological Seminary and ordained by Western Kentucky Presbytery in September of 1993, she later received her Doctor of Ministry from Columbia Theological Seminary in 2006. A Presbyterian since birth, Ann Marie and her husband David served as co-pastors for almost 20 years in Murray, Kentucky before moving to Toledo. She served as interim pastor at First Presbyterian in Huron, Ohio, as well as (until

very recently) the part-time pastor at First Presbyterian in Adrian, MI. Throughout her ministry, Ann Marie brought her creativity, spiritual depth, and artful expression to all her pastoral and presbytery work, active with our Committee on Ministry, Spiritual Formation Team, Commissioned Ruling Elder Training program, and as a Retreat Leader.

She is survived by her husband David, her three grown sons Michael, Philip, and Stephen who live in Kentucky, Michigan, and North Carolina; siblings Franny, Billy, and Diane; three grandchildren who knew her as "Gigi", and many others. David and Ann Marie made their residence in Toledo, OH, where David continues to reside, even as a minister member of Detroit Presbytery.

A memorial service for Ann Marie was held Saturday, January 6, 2024 at 11:00am at Cadmus Presbyterian Church in Adrian, Michigan. Memorial contributions may be sent to Cadmus Presbyterian Church (6838 W Cadmus Rd, Adrian, MI 49221; First Presbyterian Church, Murray, KY; or NW Hospice of Ohio.)

# **Actions Taken on Behalf of Presbytery:**

1. Appointed the following Moderators of Session:

The Rev. Dr. Matt Meinke as Moderator of Cadmus Presbyterian Church, effective Dec. 7, 2023.

The Rev. Clint Tolbert as Moderator of First Presbyterian Church, Napoleon, OH, effective January 1, 2024 for a 6- month period.

The Rev. Doris Chandler as Moderator of Collingwood Presbyterian Church, Toledo, OH, effective February 12, 2024.

The Rev. Mary Beth McCandless as Moderator of First Presbyterian Church, Adrian MI, as of March 1, 2024

Ruling Elder Bill Treadway (FPC Tiffin) as Moderator of Waterville Presbyterian Church beginning March 1, 2024 upon approval of additional compensation. Bill is the part time Transitional Pastor at Waterville, and has completed a Presbyterian Polity course as part of his seminary education.

- 2. Approved the part time temporary supply contract between the Rev. Dorothy Kaiser and Market Street Presbyterian Church, with exception to minimum standards granted, effective January 1, 2024; equivalent of \$ 36,400 salary & housing (contract reads \$ 700 per week) with reimbursable expenses approved up to \$ 350 per event and 3 weeks vacation. Dottie is retired and not a member of presbytery.
- 3. Approved the part time temporary supply contract between the Rev. Bruce Brown and First Presbyterian Church, Napoleon, effective Jan. 1, 2024, at 20 hours per week; Cash and housing: \$ 18,720 (SECA offset \$1164) (contract was written with monthly amounts), Professional expenses & Continuing Ed allowance \$5500 medical insurance through the Board of Pensions 100% HDHP (approx. \$8,000); because of the medical insurance, exception to minimum terms granted. Vacation accrued at 1 week per quarter; continuing ed time accrued at 1 week per 6 months.
- 4. Validated Ministries

Pool - large outdoor pool; available seasonally.






