## Getting Organized MVP Moderator, Elder Carole Burnworth (Westminster), presiding

Maumee Valley Presbytery gathered at First Presbyterian Church, Monroe, Michigan, for the May 21, 2024, Stated Meeting of the presbytery.

### The meeting was called to order and opened with prayer at 3:05 p.m.

#### A quorum was declared present by Carole Burnworth.

Acting Stated Clerk Matt Meinke noted no significant changes to the docket. **The docket was moved and adopted without objection.** 

Matt Meinke moved (with support) the approval of the Minutes of February 20, 2024, as presented. **So ordered.** 

Matt moved (with support) to seat the following corresponding members with privilege of the floor: Luke Choi, Board of Pensions, Western Reserve; Lauren Rogers, Ministry Engagement Advisor, PCUSA, so ordered.

## The report of the Clerk (attached) and MVP Statistics (attached) were noted.

Rev. Dr. Doris Chandler, First Presbyterian Church, Monroe, Michigan, brought greetings from the session and congregation.

There being no first-time commissioners, all guests to the meeting were welcomed.

## **Opening Worship** including the Sacrament of the Lord's Supper

Worship was planned using the framework of the four special offerings of the PCUSA as a guide with the liturgy from the special offerings' website: <u>http://specialofferings.pcusa.org/</u> The following persons led worship: Justin Murray, Director of Music Ministry, Monroe; Rev. Douglas Holmes (Blissfield/Palmyra) and CRE Lance Weismann (Cadmus), liturgists; Lauren Rogers, Ministry Engagement Officer, PCUSA (preached a sermon based on 1 John 3:16-24); MVP Pop-Up Choir "*In This Very Room*" by Ron and Carol Harris; Rev. Dr. Doris Chandler (Monroe) and Rev. Tom Steensma, HR, presided at communion.

# Report from PMA Lauren Rogers, Ministry Engagement Officer with the PCUSA

Lauren reminded folks that they could sign up as online observers for the 226<sup>th</sup> General Assembly and encourage commissioners to watch the livestream of the committees or plenary sessions. She announced upcoming new cohorts for new church development. The Lily foundation is funding a program for fostering faith at home (through prayer, hospitality, etc.) Lauren noted that this year is the 75<sup>th</sup> Anniversary of the One Great Hour of Sharing offering and encouraged congregations to remember that they can receive any of the four offerings at any time during the year. She concluded her report by handing out certificates to the congregations in our presbytery who were 4 for 4 givers to the Special Offerings.

## Report about Board of Pensions Changes Luke Choi

Luke Choi gave a 30-minute report on the 2025 changes for Board of Pensions. All information is on the Board of Pensions website: <u>http://pensions.org</u> (then click on "A New Benefits Plan to Serve the Changing Church.") Luke suggested that session leaders be included in upcoming Zoom and other training events and that he is available to talk with sessions and/or pastors to help congregations make their best decisions. He reviewed the benefit plan options and encouraged congregations to offer some benefit to every employee.

The body recessed for dinner with prayer (Rev. Doris Chandler) at 5:25 pm.

The meeting was **reconvened** at 6:34 pm with a call to order by Moderator Carole Burnworth.

# The moderator invited those requesting time for Good News Reports to share.

Rev. Ann Wasson (FPC, Defiance) announced the new collaboration in shared ministry between FPC Defiance and St. Johns UCC in Defiance. She also announced that the congregation had received a grant for their *Tools for Schools* program and that they anticipate serving 400 students this year. *Tools for Schools* now has a community steering committee so that the leadership for this ministry is shared beyond the FPC of Defiance. To date \$9000 has been received from the community plus a portion of their Pentecost offering also goes to this ministry.

Rev. Amy Remaklus (Toledo Campus Ministry) announced the celebration of graduation on campus plus the re-start of the Crop Walk. (Watch for announcements.)

Rev. Ruth Clendenin (Christ Church, Toledo) announced that Jonathan Sikes, Mission Coworker in Taiwan, would be preaching at Christ Church in July. (Watch for announcements.)

There was no Synod Report.

### General Presbyter's Report Matt Meinke (4, 4a, 4b)

Matt Meinke shared that Rev. Jack Hess has entered hospice care and has moved to be near his daughter; that Lora Manon has requested prayer for a significant health challenge for which she is dealing with testing; Rev. Diane Christopherson (UCC) has requested prayer (recurrence of cancer); Rev. Matthew Zuelke (Bluffton Church) requests prayer as he undergoes testing. Matt reviewed highlights of his report and shared the land acknowledgement for the ground on which the Monroe church sits.

### Actions

ON MOTION to approve the Terms of Call 2024 Report as presented with the correction of the date in the heading to 2024, (attachment 5a) motion passed.

## Actions Taken on Behalf of Presbytery:

 Approved the supply contract between First Presbyterian Church, McComb Ohio and CRE Julie Fogle effective January 1, 2024: Salary \$ 23,048; Housing \$ 10,000, reimbursable expenses \$ 4000 and continuing education \$ 1200 with 4 weeks vacation and 2 weeks study leave, including Sundays. This is a 3/4 time contract.
Appointed Cathi King as Moderator of First, Adrian, MI beginning in March 2024;
Approved the supply contract between CRE Lance Wiesmann and Cadmus Presbyterian Church, Adrian, MI, with permission to do sacraments (CRE) through June 1, 2024.
Having completed their training on 2/29/2023, the following Ruling Elders are approved to serve communion when invited by the session of their church: Scott Elliot (FPC Adrian) and Marilyn Smith (FPC Adrian).

Approved Shared Ministry Covenant between First Presbyterian Church, Defiance OH and the St John United Church of Christ, Defiance OH, effective April 15, 2024. The terms of call for the Rev. Ann Wasson will be shared 50/50 between the 2 congregations.
Approved the call and its terms between Bluffton Presbyterian Church and the Rev. Dr. Matthew Zuehlke, effective May 19, 2024 with the following terms:

Cash Salary \$ 50,150 Manse Value 15,045 Utilities paid by the church \$ 6,286 SECA (7.65%) 3,600 Full coverage Board of Pensions Health Reimbursement plan \$ 2,000 Professional Expenses 4,000 Continuing Education Allow. 1,500 Vacation: 4 weeks incl. 4 Sundays annually; Continuing Education Leave: 2 weeks incl. 2 Sundays annually; reasonable moving expenses; 3 month Sabbatical following 7 years continuing service to Bluffton Presbyterian Church.

7. Gave permission to First Presbyterian Church, Adrian, MI to form a PNC.

### Several items for information about upcoming events were offered to the presbytery.

Amy Remaklus shared information on upcoming boundary training.

Sara Hodsden reported Scott Elliot of Adrian has enrolled in the CRE track for the presbytery. Teaching and Ruling Elders are needed to serve on the care teams for people discerning.

Pamela Short reported that the spiritual formation committee is offering a fall retreat Oct. 13, 14, 15 at Lial and two quiet day retreats at her home on Lake Diane in Michigan on Monday, July 15 and Thursday, August 15.

David Bartley announced the *Rekindle Retreat* will be Nov 8-10 at Kirkmont; he also announced summer camp registration is open for Kirkmont.

David Hammond invited presbyters to a curriculum overview of the *Follow Me* curriculum on June 12 via Zoom. A 20% discount on *Follow Me* downloads is available in June for those who attend or view the recording of the event.

Clint Tolbert talked about an upcoming event November 16 at FPC Maumee on *"Attentive Church Leadership* (a book by Kevin Ford and Jim Singleton.)

Jessie Commeret announced an upcoming educational event September 28 in Findlay.

### **Report of Mission Commission** (attachment 7)

The following actions were taken on behalf of the presbytery:

1. Moved to send \$1,000 to help sponsor a Presbytery wide event to bring Hunter Ferell and/or Bala Khyllep to discuss their book Freeing Congregational Mission. This would be from Acct #5374, the Matthew 25, economic justice, line of the budget. – Sept 28 – presbytery event.

2. Moved to release \$1000 from the Peace and Global Witness Designated fund for the International Mission Trip to Mexico sponsored by First Presbyterian Church of Bryan and First Presbyterian Church of Defiance. The intention is for this to be a matching grant to congregational financial support. Funds will be issued from Acct #7506-506, but deducted from Acct #3506-506, per Belinda King.

Leo Pech shared there has been some turnover in the membership of the commission due to illness and moves. He also noted that some of the commission is on a mission trip in South Africa and will report upon their return. The group that is going to Mexico this summer is preparing for that work. Congregations are encouraged to apply for Matthew 25 grants.

### New Worshipping Communities Commission (attachment 8)

Jason Armstrong, chair (RE, Maumee) The commission held meetings on April 17 and May 2, 2024. All members were present for both meetings. Doug Holmes (Blissfield/Palmyra) reviewed the work that had been done previously under the Mission Commission. Jason contacted the new regional liaison, Gad Mpoyo. Gad suggested that we hold an Exploring Missional Leadership training event for the Presbytery in conjunction with another presbytery if possible. Future meetings will be held via Zoom on the first Thursday of the month at 5PM. At the next meeting the process for how a group can become a New Worshiping Community will be reviewed.

## **Central Support Commission**

Chas Myers, chair (RE, Ottawa) Reported the actions of the Central Support Commission taken at their April 23, 2024 meeting (attachment 9).

## Approved a uniform 5% draw on investments instead of two different levels.

Rev. David Bartley (HR) informed Central Support that there were two different draws on endowments (4% and 5%) and upon his recommendation--ON MOTION to make the draw 5% in all instances drawing from endowments. *So Ordered*.

### Approved wording changes on Pastoral Care Fund to match our new structure.

Rev. David Bartley reported that there is a residual of \$1250 in the Mobile Health Fair funds and this will be advertised to churches so that if a member church is doing a similar mission they can apply for the funds. The Pastoral Care Fund description needs to be updated – ON MOTION to change wording "Presbyter for Common life" to "General Presbyter" and "Committee on Ministry" to "Leadership Commission" *So Ordered*.
