For our Common Life:

1 Land Acknowledgement: Highlight of the Shawnee



Along with the Ottawa, Myaamia, Seneca-Cayuga, Lenape, and Wyandot, the Shawnee were displaced people, finding their way to the Western and also Southern edge of Ohio for many generations. They became beacons of resiliency as all the Ohio Indians endured warfare, invasion, resettlements, and colonial expansion through the 1600s, 1700s, and 1800s. The Shawnee forged new alliances, helping foster a collective identity between once autonomous or long-separated bands,

cooperating more closely, approaching modern definitions of "tribe" or "nation". For their collective and community spirit we give thanks for the Shawnee people, and all the Historic Native Peoples of Ohio, even as we grieve the violence done to their native language, cultures, and personhood.

If you ever find yourself in Miami, Oklahoma, I would encourage you to visit the Shawnee Tribe Cultural Center: <u>www.shawneeculture.org</u>. It is an extraordinary testament to their resiliency.

2 Collaboration at Hanmi –

I want to say a great big THANK YOU to Ed Bettendorf, Rev. Jin Sung Kim, Wes Bella, and others who participated in the Fence Repair project at Hanmi Church in Toledo on October 26. This "Good Neighbor Repair Team" was made up of a work crew from Firelands in Port Clinton, Hanmi Covenant Presbyterian Church, the uToledo Student Ministry of Hanmi Covenant, and the Presbytery office totaling 9 workers. We were able to replace three posts and three panels in less than 3 hours, in addition to other repairs. Thanks to Rev. Kim for providing us lunch and a time to share stories with one another!



3 Changes at the National Office

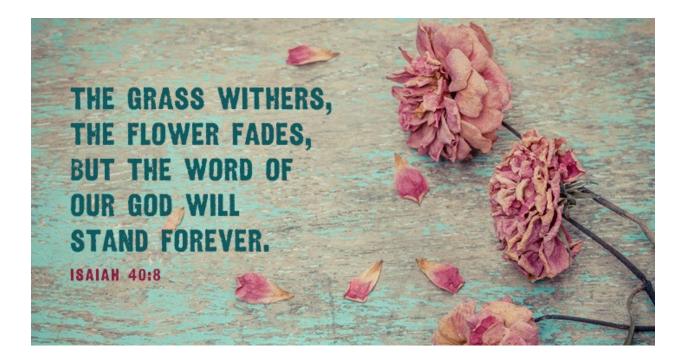
On November 4, Dean and I received an email from the National Office regarding changes with the staffing of the Interim Unified Agency (IUA), formerly the Presbyterian Mission Agency and the Office of the General Assembly. The short version of this is that a reduction-in-force occurred on Nov 1 that impacts a variety of programs, including the Peacemaking Program, Vital Congregations, Theology and Worship, resources for Stated Clerks, and the Presbyterian Historical Society.

I am not sure I want to go into the long version of this story, because it is clear to me from the email that MORE CHANGES are coming. This appears to be the long-overdue staffing reconfiguration that has been needed for some time, and the moving parts are still moving. That doesn't make it any easier, especially when one of my good friends was directly affected and is without employment.

Dean and I are in communication about the impacts to presbytery function, and we will alert you to changes as they become relevant. Talk to us if you want to understand this more fully.

Amidst all the changes and challenges that come to us, locally, nationally, politically, culturally, it is fair to say that stress is high. Predictability and normalcy in ministry seem elusive. Be praying for the staff who were affected by these changes, and continue to hold our whole denomination in your prayers as we seek new ways to follow faithfully.

- 2. Appointed the Rev. Jessica Commeret as appointed Moderator of Van Buren presbyterian Church effective October 28, 2024;
- 3. Appointed the Rev. Dave Bartley, H.R. as Moderator of Fairgreen Presbyterian Church, Toledo, OH effective November 11, 2024;
- 4. Appointed the Rev. Tawee Layraman, H.R. as Moderator of West Eagle Creek and West Bethesda Presbyterian Churches, effective October 28, 2024;
- 5. Approved the pulpit supply contract between First Presbyterian Church, Adrian MI and Ruling Elder Scott Adair (professor of Religious Studies at Adrian College). The contract includes leadership for Sunday worship, faith formation, and communications; at \$ 600 per week, for one year. Since Scott is also an Inquirer, the Discipleship Commission will have oversight of this relationship as well.

The Vision Team will have periodic articles in the presbytery newsletter on the topic of shared ministry and other ideas to strengthen the churches in our presbytery.

Date:	November 5, 2024

The Spiritual Formation Team met on Monday, October 28 at the Presbytery office in Findlay. The following items were reported/discussed.

A report on recent Fall Spiritual Formation Retreat which was held October 13-15, 2024 was given which included 7 participants, and 2 retreat leaders, Pamela Short and Joyce Nafziger. Two other people had scheduled, but one canceled on Sunday and one had a family emergency on Monday. We are grateful to all who voluntarily prepared and served delicious meals: Nancy Dermyer of our Monroe church; Gloria and Randy Box, Kaye Spicer, Chris Weith, and Becky Johnson all from Waterville Presbyterian.

Pamela reported on the exploration into John Philip Newell as a retreat leader. His honorarium for leading 5 sessions similar to our current Lial retreat would be \$10,000.00 plus travel expenses and lodging. Bob Butcher expressed theological differences that may be present, such as Newell following the theological bent of Pelagius, rather than Augustine. Newell is rooted in Celtic spirituality. The team agreed that the cost was too much for our Presbytery to bear, but that a conversation with Rev. Dr. Chip Hardwick, Synod of the Covenant Executive may be useful.

Additional suggestions for future retreat speakers included:

Cindy Halverson of the Synod Leadership Network Speakers from PCUSA A retreat on eco spirituality using the book *Church of the Wild, How Nature Invites Us Into the Sacred* by Victoria Loorz. Tom Polker leading a silent retreat

A concern was expressed for spiritual formation opportunities for our ruling elders and other folks in the pews. While they are consistently invited to the Lial retreats, very few attend. It was suggested that one day events might be more appealing. Also, the idea of holding events in different regions of the Presbytery may highlight what each region has to offer. Thus, two opportunities were suggested with ruling elders and regions in mind:

Call to Order with Prayer – Moderator of Central Support Chas Myers opened the meeting with prayer at 1:00pm. Matt noted Dean's planned vacation and that he had been asked to serve as Acting Clerk.

Report of the Nominating Team – Slate was presented (in the packet). Peter discussed the remaining vacancies and recent additions to the slate: Nan Clancy for Vice Moderator and Chas Myers for Discipleship.

ON MOTION (Ed, Carole) to recommend to presbytery the nominating slate as presented, with the addition of Nan Clancy for Vice Moderator. (Chas Myers volunteered for Discipleship if there was an opening, but both positions had been accepted/filed). Approved. (See attached slate)

Clerk's Report – Acting Clerk Matt Meinke presented the August minutes, noting a couple corrections. ON MOTION (Peter/Ed) to approve the minutes of the August 20, 2024 meeting. Approved.

Treasurer's Report: Financials presented. David Bartley spoke of the upcoming endowment draw, the outstanding per capita, and encouraged the presbytery and individuals to consider mission pledges to the presbytery.

Amendment to Synod Bylaws (see attachment): The clerk reported that any Synod Bylaw change must be ratified by a majority of presbyteries. Discussion. ON MOTION (Doug/Peter) to recommend to the presbytery the amendment to the Synod Bylaws (see attached). Approved.

Moderator's Report – Carole Burnworth thanked Doug for moderating in her absence, reported Amy Remaklus' plan to be installed in the Spring, and reported her plans to participate in Erie's closing service on November 3. She will also be doing some PNC training at Market Street in Lima on 10/29.

Vice Moderator's Report – Doug Holmes reported on host sites, his on his plans to register for Moderator's Conference hosted by the national office, and plans for the next worship service.

General Presbyter Report - Matt Meinke reported on staff/pastoral concerns including the medical leave of our primary website/technology staff person. He also spoke of a reworked job description proposal coming most likely in January to Personnel.

Delinquent Per Capita Task Force Report - Ed Bettendorf - No report

Task Force for Grand Rapids and Bucyrus - Ed Bettendorf - No report

Central Support as Trustees Report – Ed Bettendorf reported on the Hanmi/neighbor/fence issue, local ordinances, and survey on Hanmi's property. Ed reported the recent letter from the neighbor's attorney agreeing for us to enter their property for the purpose of repairing Hanmi's fence, a repair that is planned for this Saturday and will include a team from Hanmi, Firelands in Port Clinton, as well as Matt, with Wes Bella coordinating.

ON MOTION (Ed/Doug) that the payment of repairs by the trustees, and authorization for reimbursement, come from #5052 and #5016, not to exceed \$400 dollars. Approved.

Ed also reported on the \$1 Lease/Lien issue that the neighbor has agreed to, noting that motion will come as a recommendation from Hanmi's congregational meeting for presbytery concurrence. Discussion. There was consensus that an email vote would be sufficient for Central Support to affirm Hanmi's recommendation, so it could possibly make the November presbytery meeting.

Docket Planning for November MVP Meeting: -

Chas spoke to Susan Rowland Miller's proposal and the plans for Ann Wasson and her team to enact much of that proposal, and plans for the next meeting to include Open Spaces in the midst of the meeting. Rekindle Retreat. CCCM needing 15 minutes.

Other Business Carole spoke to the desire for a new time/date for the next meeting. It was agreed the next meeting will be at 12:30pm on January 21st.

ON MOTION to adjourn at 1:55pm. So Ordered.

AMENDMENT TO THE SYNOD OF THE COVENANT BYLAWS:

To approve the Each at-large member shall be elected to serve terms of three years and may be eligible for re-election. However, no at-large members shall serve more than six consecutive years, and any at-large member who has served six consecutive years shall be ineligible for election as an at-large member for at least one year.

- A. At-large members will have voice and vote on the committees to which they are assigned, as well as voice and vote at Synod Assemblies.
- B. Each at-large member shall be a ruling elder or a teaching elder.
- C. Each at-large member shall be a member of a presbytery or congregation within the bounds of the Synod of the Covenant.
- D. No more than one (1) at-large member from each presbytery can serve simultaneously.

following proposed amendment: To add 40:80 In order to fulfill the principles of participation and representation, the Synod shall elect three ruling elders and three teaching elders as at-large members as follows: two people of African descent, two people of Asian, Asian American, or Pacific Islander (AAPI) descent, and 2 people from marginalized communities within the bounds of the Synod (member of another racialized identity, immigrants, those whose first language is not English). Two of those elected will be assigned to serve on the Leadership Committee, and the other four will be assigned, one each, to one of the other standing committees by the Nominating Committee.

Rationale: At the Annual Assembly in October 2023, Commissioners approved the following motion: To increase the number of Synod Commissioners by six. The composition of those six will be designated as follows: two Commissioners of African descent, two commissioners of Asian, Asian American, or Pacific Islander (AAPI) descent, and 2 Commissioners marginalized communities within the bounds of the Synod (member of another racialized identity, immigrants, those whose first language is not English). Two of these commissioners will serve on the Leadership Committee, and the other four will be assigned, one each, to other standing committees.

Constitutional Support: F-1.0403, G-3.0103, G-3.0401

NOTE: Per PCUSA Constitution, changes in bylaws or policies that alter the composition of synod membership must be approved by presbyteries that comprise the synod. If this amendment to the bylaws is approved, it will be forwarded to presbyteries within the bounds of the Synod of the Covenant for ratification. The results of those votes will be provided in the clerk's report at the Synod Assembly in October 2024.
